The Tender Notice is also available on the websites of PPRA and NHMP.
- b. Tender should be accompanied by bid money as mentioned in the tender documents as earnest money (refundable) in the name of **Inspector General of Police, NHMP**. Cheques will not be acceptable. Moreover, the successful bidder shall furnish performance security equivalent to 5% of the total value of the contract. The security shall remain with this department till warranty period.
