NOTIFICATION

*Islamabad, the 29th September, 2016*

**S. R. O. 934(I)/2016.**— In exercise of the powers conferred by section 17 of the National Highways Safety Ordinance, 2000 (XL of 2000), read with section 90 thereof, the Federal Government, in consultation with the National Highways and Pakistan Motorway Police, is pleased to direct that the following amendment shall be made in the National Highways and Motorway Police Drivers Licensing Authority Rules, 2014, namely:—

In the aforesaid Rules,—

(A) after rule 25, the following new rule shall be inserted, namely:—

- “26.— **Road Safety Training Institutes.**—(1) For the purpose of ensuring road safety and maintaining good order on national highways and motorways, Road Safety Training Institutes (RSTIs) are hereby established at the districts and stations specified in Schedule-V.
- (2) The RSTIs, established under sub-rule (1), shall focus on imparting road safety training and education to the beginner drivers and licensed drivers.
  - (3) In addition to sensitize public at large towards road safety, some of the RSTIs shall work as facilitation centers for DLA in processing applications for grant of driving licence, data entry of candidates, medical fitness and theoretical and practical tests of the candidates, for the purpose of issuance of driving licence to successful candidates by the DLA.
  - (4) A police officer of the National Highways and Pakistan Motorway Police, not below the rank of Deputy Superintendent of Police or Chief Patrol Officer, shall be Chief Instructor of the RSTI who shall, with support of adequate staff specified in Schedule-VI, be responsible for imparting road safety training and education and managing all affairs of the RSTI.
  - (5) The Chief Instructor shall ensure that all lessons in the RSTI are strictly in accordance with the law, approved training module and course contents specified in Schedule-VII.
  - (6) The expenditure and human resource required for establishment and operation of the RSTIs shall initially be met from within existing budgetary allocation and available strength of the National Highways and Pakistan Motorway Police.
  - (7) A person desirous of admission in an RSTI shall make an application along with the required documents and undertaking on the format as set out in Schedule-VIII.
  - (8) Scrutiny of the application and documents under sub-rule (7) shall be made by the RSTI and call for admission shall be issued to the applicant on first come first serve basis.
  - (9) Before admission under sub-rule (8), the selected applicant shall be required to—

- (a) obtain a learner permit from the DLA;
- (b) deposit one-time course fee, specified at serial number 15 in Schedule VIII, in Government Treasury or concerned branch of the National Bank of Pakistan; and
- (c) provide copy of the learner permit and original bank receipt evidencing deposit of the course fee.
- (10) The Chief Instructor concerned shall, for the purpose of internal and external audit, be responsible for maintaining accounts of the RSTI and cash book, in accordance with the rules and instructions of the Federal Government.
- (11) In performance of their functions for efficient administration of the RSTI, the Inspector General of Police, Zonal Commander or Deputy Inspector General of Police, Senior Superintendent of Police or Sector Commander and Deputy Superintendent of Police or Chief Instructor shall exercise their powers in accordance with the rules, instructions and regulations of Federal Government and the administrative and financial powers delegated to them.”; and

(B) after Schedule IV, the following new Schedules shall be added, namely:—

**SCHEDULE-VIII***[See rule 26(5)]***(a) COURSE CONTENTS**

All trainees shall be given lessons in the prevalent traffic laws, rules and regulations regarding highways, motorways and motor vehicles, enacted in Pakistan while utilizing technological advancements. A uniform syllabus containing the principles of safety, road sense, traffic awareness and traffic vehicle maintenance shall be taught in these institutes. The syllabus shall be revised from time to time duly approved by the Inspector General. The Class rooms shall be minimum 25 ft. x 30 ft. in size equipped with following training aids. On completion of driving course with at least 06 hrs of theoretical class attendance and 09 hrs of practical training, the candidate is liable to undergo a sign test as well as road test jointly conducted by Chief Instructor and Instructors on the specified parameters. Some of the parameters are as under:

- (i) Parallel parking.
- (ii) Use of brakes.
- (iii) Use of indicators.
- (iv) Road sense.
- (v) Over taking.
- (vi) Lane discipline.
- (vii) Awareness about sign boards.
- (viii) Reverse driving.

**(b) TRAINING AIDS**

(1) Each Road Safety Institute shall be equipped with necessary training aid items particularly:—

- (i) Specially designed vehicle (HTV, LTV, M.Car, M.Cycle).
- (ii) Simulator.
- (iii) Multimedia.
- (iv) Computer.
- (v) White board.

(2) Road Safety Institute shall be furnished with all the necessary equipment and furniture along with posters *i.e.* traffic signs and signals, etc.

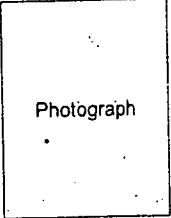
